Subject: Petition of Maharashtra Industrial Development Corporation for seeking clarification in respect of Orders of Case No. 19 of 2012 dated 16.08.2012 and Case No. 38 of 2014 dated 11.06.2014 regarding date of applicability of PWW Tariff for MIDC's Water Works & Sewage Treatment Plants.

- **Case No. 146 of 2014**

Maharashtra Industrial Development Corporation has submitted a Petition under affidavit on 05.08.2014 under Regulations 92, 93, 94, 95 & 96 of MERC (conduct of business) Regulations, 2004, for seeking clarification in respect of Orders of Case No. 19 of 2012 dated 16.08.2012 and Case No. 38 of 2014 dated 11.06.2014 regarding date of applicability of PWW Tariff for MIDC's Water Works & Sewage Treatment Plants.

2. The main prayers of the Petitioner are as under-

"i) this Hon'ble Commission may be pleased to direct the MSEDCL to apply HT IV category tariff to the Applicant's water works and sewage treatment plants from 1st August, 2012 onwards;

ii) the claim of the Applicant in respect of the tariff items be clarified and / or the claim of the Applicant be allowed;

iii) for such further and other relief as this Hon'ble Commission may deem fit."
