- d) Award costs of these proceedings against the Respondent and in favour of the Petitioner; and
- e) Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case."

- "a) Pass an ad-interim ex-parte order directing Respondent No.1 to immediately adjust the banked units to the tune of 46,43,684 units;
- b) Confirm the ex-parte orders after notice to the Respondents; and
