Subject: Petition of M/s. Arihant Universal Realty Pvt. Ltd. for under Section 142 of the Electricity Act 2003 for Non-compliance of the Order passed by CGRF, Bhandup Zone (Order No. 329 dated 09.07.2010).

- **Case No. 134 of 2014**

M/s. Arihant Universal Realty Pvt. Ltd. has submitted a Petition under affidavit on 14.12.2012, under Section 142 of Electricity Act, 2003 for non-compliance of the Order passed by CGRF, Bhandup Zone (Order No. 329 dated 09.07.2010).

The main prayers of the Petitioner on page No. 2 of the Petition are as under-

*“Please give the directives to concerned officers i.e. EE Panvel, EE Nodal Officer Vashi, SE Vashi Circle, and CE Bhandup Zone for releasing the refund estimated amount of Rs. 45,28,0201/- (Rupees Forty Five Lakhs Twenty Eight Thousand Two Hundred and One Only) which are inclusive of supervision charges, miscellaneous, labour, transport & handling charges etc. Sir, due to this non compliance of SOP directive & orders of CGRF Bhandup Zone, we are facing additional interest burden.*

*Requesting you to please give the directives to MSEDCL Bhandup Zone to refund the estimate amount of Rs. 45,28,020/-”*

The main prayers of the Petitioner on page No. 6 of the Petition are as under-

- “a) That records and proceedings be called for and perused;*
- b) That the Opponent be directed to comply with the order and direction dated -----of the Hon’ble Forum;*
- c) That the Opponent carry out the necessary acts in providing for utility under the scheme as applied for;*
- d) That the opponent be directed not to restrict the Applicant to a scheme which will be detrimental when options are available under the act and governing law;*
- e) Such other and further relief be granted as deemed fit and proper considering the facts, circumstances and conduct of the opponent.*
- f) It is also prayed that the compensation to the applicant be allowed for harassment and compelling the applicant to carry out the work on his own by shirking away the directions of the forum.”*

3. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 11 November, 2014 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
