*d) To Pass such further and other order/relief as the Hon’ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*

*e) Condone any error/omission and to give opportunity to rectify the same;*

*f) Permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.”*
