The main prayers of the

The main prayers of the Petitioner are as under-

“a) To admit the Petition as per the provisions of the Section 86(1)(f) of the Electricity Act, 2003 & Regulation 100 of MERC (MYT) Regulations, 2011;

b) To waive off surcharge claimed by STU for delay in payment of revised transmission charges by MSEDCL for FY 2012-13, 2013-14 and thereafter;

c) To provide relief to MSEDCL on payment of any surcharge on delayed payment in case extra-ordinary situation arises and if there is time gap between the approval of tariff to MSETCL and recovery thereof allowed to MSEDCL;

d) To grant any other relief as the Hon'ble Commission may deem fit;

e) To Pass any other order as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;

f) To condone any error/omission and to give opportunity to rectify the same;

g) To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.”
