Gopal Shankar Dhote (Through authorised representative Pramod Narayan Khandagale) has submitted a Petition under affidavit on 07.08.2014 under Sections 142, 146 & 149 of the Electricity Act, 2003 for seeking action against Respondents for Non-compliance of the Regulation 5.4.1 of MERC (General Conditions of Distribution Licensee) Regulations, 2004.
