Subject: Petition of Shri Nathu Gangadhar Rambhad for directions to the Respondents under Section 86 (1) (i) of the Electricity Act, 2003 for refund of bill amount fraudulently and under duress collected on the pretext of application of commercial to transformer repairing industries.

Nathu Gangadhar Rambhad has submitted a Petition under affidavit on 16.06.2014, under Section 86 (1) (i) of Electricity Act, 2003 for seeking directions to the Respondents for refund of bill amount fraudulently and under duress collected on the pretext of application of commercial to transformer repairing industries.

“The petitioner prays that by an appropriate order, The Respondents be directed to repay the entire amount of Rs. 91,130.00, plus Excess payments recovered by way of difference in Commercial tariff and industrial tariff along with taxes and interest on the amount as per ‘Micro, Small and Medium Enterprises Development Act. 2006’.”
