The main prayers of the Petitioner are as under -

*“Mahavitaran failed to make payment. We have reminded Mahavitaran on 28.05.2014 and on 12.06.2014 (copies enclosed) but there is no any response hence we are filing this complaint for non compliance with CGRF order. Under Section 142 of E.A. 2003. We request you to order Mahavitaran to make payment of Rs. 43780/- + Rs.1000/-+ interest as per Bank rate immediately.”*
