Subject: Petition of Shri Sudhakar Rajaram Ambiyee (Through authorised representative Mrs. Sonal Sudhakar Ambiyee) for u/s 142 & 146 of the Electricity Act, 2003 against MSEDCL for non-compliance of Order dated 16.07.2013 passed by CGRF, Ratnagiri.
- **Case No. 155 of 2014**

Sudhakar Rajaram Ambiyee (Through authorised representative Mrs. Sonal Sudhakar Ambiyee) has submitted a Petition under affidavit on 24.06.2014, under Section 142 & 146 of Electricity Act, 2003 for non-compliance of the Order of CGRF Ratnagiri dated 16.07.2013.

The main prayers of the Petitioner are as under -

“a) Complaint filed by the Complainant may kindly be resolved and the Respondent directed to comply strictly with order dated 16.07.2013 passed by Ld. Consumer Grievances Redress Forum, Ratnagiri Zone in Consumer Complaint No. 10 of 2013

b) Maximum monetary fine may be charged on the Respondents as per the provisions of S. 142 & 146 of Electricity Act for non-compliance of order dated 16.07.2013.

c) Cost of present Application may be awarded.

d) Any other order as this Hon'ble Commission sees fit.”
