Tata Power Company Ltd. has submitted a Petition under affidavit on 25.08.2014 under Regulation 85(a) of MERC (conduct of business) Regulations, 2004 for Review of MERC Order in Case No. 99 of 2013 with regards to disallowance of capitalisation.

The main prayers of the Petitioner are as under-

*“ a) Condone the delay of about 400 days and admit the review petition in accordance with Regulation 85 (a) MERC (conduct of business) Regulations, 2004;*

*b) To consider the revised capitalization of Rs. 187.93 Crores for FY 2011-12 instead of Rs.183.33 Crores as considered for the ROE and interest computation.*

*c) Appropriate directions from the Hon'ble Commission it deems fit.”*
