- B) The main prayers of the Petitioner in main Petition are as under –
- "On the premises aforesaid, the Review Petitioner most humbly prays that this Hon'ble Commission may be pleased to review the decision / findings of the order in Case No. 189 of 2013 dated 15.07.2014 and in Case No. 140 of 2014 to the extent as follows:
- a) To enable full recovery of cost of alternate coal considering actual generation covering the incremental cost incurred for the alternate coal procured to bridge the shortfall as suggested in Para 14.
- b) declare that the Change in NCDP, 2007 by the NCDP dated 21.06.2013 is an event of Change in Law in terms envisaged under relevant Articles of the PPAs dated 08.09.2008, 31.03.2010, 09.08.2010 and 16.02.2013 and that the Review Petitioner is entitled to appropriate remedial relief in terms of the PPAs dated 08.09.2008, 31.03.2010, 09.08.2010 and 16.02.2013 executed between the Respondent MSEDCL and the Review Petitioner.
- c) Allow Compensatory fuel charge from the date which is later of (a) date of MoP Advice (31 July, 2013); and (b) Actual Date of Delivery.
- d) pass such other order or order(s) as this Hon'ble Commission deems fit in the facts circumstances of the present case."
