

NOTICE

Subject: Petition of Westin Garden City Mumbai. (A Unit of Oberoi Realty Limited.) for seeking relief under clause 44.4 of the Distribution Open Access Regulations 2014 and the relevant rulings / clauses of Electricity Act, 2003 (with amendments).

- **Case No. 175 of 2014**

Westin Garden City Mumbai (A Unit of Oberoi Realty Limited.) has submitted a Petition under affidavit on 07.10.2014 under Regulation 44.4 of the MERC (Distribution Open Access) Regulations 2014 for seeking directions / orders relating to Open Access Regulation 2014, scheduling charges & credit reports for the generation of power from 1st July 2014 & for giving the credits in the energy bills.

The main prayers of the Petitioner are as under:-

“Therefore, the petitioner requests the Commission to give the following reliefs to the petitioner

1) By deferring the implementation date of the new regulation for all open access transactions of renewable energy effective from 01st April 2015.

2) By extending the status quo ante granted in orders in the case No. 106 of 2014. till such time the Utilities / SLDC come up with their Commission approved procedure and all the affected parties are clear about the same.

3) By directing the respondents 1 & 2 to issue open access Permissions from the date of our application (01.07.2014) and directing SLDC to give credits for all the generated units in our energy bills.

4) To clarify that SLDC should not levy the scheduling charges for renewable energy open access transactions for all intra state open access.”

Having submitted the above, the Petitioner now Pray before the Hon. Commission without prejudice:

a) To suitably amend the implementation of the Distribution Open Access Regulations 2014 for all the open access transactions effective from 01st April 2015.

b) To pass suitable orders to respondent to issue open access permission and the credit reports for the generation of power from 1st July 2014.

c) To pass suitable orders for giving the credits in the energy bills of, the petitioner(consumer).

d) To clarify that SLDC should not levy the scheduling charges for renewable energy open access transactions for all intra state open access.

e) To pass any suitable orders to give relief to us as we are financially affected party.

f) To permit us to amend / modify / add / delete any of the points during the course of hearing if needed. ”

3. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 13 November, 2014 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to serve a copy of the above mentioned Petition along with its accompaniments (both in soft and hard version) to the Respondent and the authorized consumer representatives, whose addresses are given below.

5. The Respondent is directed to submit its say, if any, on the above mentioned Petition with a copy served to the Petitioner and the authorised consumer representatives.
