PUBLIC NOTICE

Suggestions/objections on the Petition filed by Vidarbha Industries Power Limited for determination of Capital cost and Final Tariff for FY 2014-15 and FY 2015-16 for 2x300 MW Generating station at Butibori [Case No. 115 of 2014]

- 1. M/s. Vidarbha Industries Power Limited (VIPL) has filed a Petition for determination of Capital Cost and Final Tariff for FY 2014-15 and FY 2015-16 for its 2x300MW Generating Station at Butibori before the Maharashtra Electricity Regulatory Commission (MERC) under Sections 61, 62 and 86(1)(a) & 86(1)(b) of the Electricity Act, 2003 (Act) and as per Part A, B, C, E, F & K of MERC (Multi Year Tariff) Regulations, 2011. Both the units of VIPL have been commissioned and the power is being supplied to R Infra- Distribution Business from 1st April, 2014. MERC has admitted the Petition on 13 October, 2014 and directed VIPL to publish a Public Notice under Section 64(2) of the Act, for inviting suggestions and objections from the Public through this Notice.

It should also be mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public Hearing to be held at the Maharashtra Electricity Regulatory Commission, World Trade Centre, Centre No.1, 13th Floor, Cuffe Parade, Mumbai 400005 on Tuesday 9 December, 2014 at 1200 Hrs, for which no separate notice will be given.
- 6. VIPL shall reply to each of the objections and comments / suggestions received within three days of the receipt of the same, but not later than **5 December**, **2014** for all the

objections and comments / suggestions received till **2 December**, **2014**. Stakeholders can submit their rejoinders on replies provided by VIPL either during the public hearing or latest by **12 December**, **2014**.
