

**NOTICE**

Subject: Petition of M/s. JSW Energy Limited for under Section 61, 86(1)(b), 86(1)(f) and other applicable provisions of the Electricity Act, 2003.

- **Case No. 160 of 2014**

JSW Energy Limited has submitted a Petition under affidavit on 15.09.2014 under Section 61, 86 (1) (b), 86 (1) (f) & 61 of the Electricity Act, 2003 for seeking relief in the circumstances arisen on account of the impact of Promulgation of Indonesian Regulation and unprecedented increase in international prices on the cost of fuel procured by the Petitioner.

The main prayers of the Petitioner are as under-

*“Wherefore, in view of the facts stated and legal grounds urged hereinabove, the Hon’ble Commission may be pleased to:*

*a) determine the additional energy charge to offset / alleviate the impact of unprecedented escalation in imported coal price and the promulgation of Indonesian Regulations;*

*b) direct the Respondent to pay the additional energy charge determined pursuant to (a) above for the period commencing from the date of commercial operation of Unit 1 of The Ratnagiri Project;*

*c) pending final disposal of this petition, fix an interim energy charge over and above the energy charge quoted by the Petitioner in the PPA so as to alleviate the financial burden being suffered by the Petitioner; and*

*d) pass such further orders or directions as this Hon’ble Commission may deem just and proper in the circumstances of the case.”*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 02 December, 2014 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
