

**NOTICE**

Subject: Petition of Nath Pulp and Paper Mills Limited for non- compliance of Order passed by Hon'ble CGRF Aurangabad u/s 142 of the Electricity Act, 2003  
- **Case No. 161 of 2014**

Nath Pulp and Paper Mills Ltd. (Through authorised representative Mr. Kashinath Iyer) has submitted a Petition under affidavit on 15.07.2014, under Section 142 of Electricity Act, 2003 for non-compliance of the Order of CGRF Aurangabad.

The main prayers of the Petitioner are as under-

*"1) Respondent may be directed to refund / adjust unpaid Additional Supply Charges of Rs.1,04,69,029 along with interest accruing thereon without further delay.*

*2) Respondent may be penalized for non compliance of Hon'ble CGRF, Aurangabad order as per provision u/s 142 of Electricity Act, 2003.*

*3) Respondent may be directed to pay compensation of Rs.50,00,000 (Rs. Fifty Lacs Only) to the petitioner due to a colossal financial loss caused to the petitioner due to illegal and deliberate disconnection of power supply by the Respondent for period 31/5/14 to 4/6/14 and Rs.1,00,000/ towards cost of this petition.*

*4) Any other relief to which the petitioner is found to be entitled to considering the facts and circumstances of the case, be granted."*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 02 December, 2014 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
