Subject: Petition of Maharashtra State Electricity Distribution Co Limited for Miscellaneous Application in Case No 123 of 2014 for approval of recovery of Additional Transmission charges payable to MSETCL (STU).

- **Case No. 171 of 2014**

MSEDCL has submitted a Petition under affidavit on 25.09.2014, under Regulations 92, 93 & 94 of MERC (Conduct of Business) Regulations, 2004 for approval of recovery of Additional Transmission charges payable to MSETCL (STU).

The main prayers of the Petitioner are as under-

“a) To allow MSEDCL by way of interim measure to recover the additional Transmission charges of Rs. 53.48 Crs as approved in the Order dated 14th August, 2014 in Case No. 123 of 2014 from consumers as per the mechanism approved in the Order dated 3rd March 2014 in Case No. 38 of 2014; till the final decision of matter remanded by the APTEL;

b) To Pass any other order/ relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;

c) To condone any error/omission and to give opportunity to rectify the same;

d) To permit the MSEDCL to make further submissions, addition and alteration to this Petition as may be necessary from time to time.”
