Subject: Petition of Shri Prakash Baburao Kale for non-compliance of the Order dated 31.08.2013 passed by CGRF Aurangabad in case No. CGRF / AZ / AUR/R/447/ 2013 dt. 09.07.2013 u/s 142 & 146 of Electricity Act 2003.

- **Case No. 185 of 2014**

Prakash Baburao Kale has submitted a Petition under affidavit on 09.09.2014, under Section 142 & 146 of the Electricity Act, 2003 for non-compliance of the Order dated 31.08.2013 passed by CGRF Aurangabad in case No. CGRF / AZ / AUR / R / 447 / 2013 dt. 09.07.2013.

The main prayers of the Petitioner are as under-

*“1) The petition may be admitted.*

*2) Respondent may be directed to withdraw the Interest and DPC amount as per CGRF order dt. 31.08.2013.*

*3) The notice of disconnection dt. 03/07/2014 and 31/07/2014 may be quashed.*

*4) Respondent No.2 may be directed to pay compensation of Rs. 25,000/- for Non compliance of CGRF order and Rs. 10000/- towards costs of filing this present petition and mental harassment.*

*5) Respondent No. 1 may be directed to pay Rs.1 / for not carrying effective monitoring over its Franchisee working.*

*6) Any other order as deemed fit by Hon'ble Commission.”*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 30 December, 2014 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the Authorised consumer representatives before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the Authorised consumer representatives well in advance.
