Subject: Petition of Adani Power Maharashtra Limited for under section 86 of the Electricity Act, 2003("the Act") read with Article 13 "Change in Law" under the Power Purchase Agreement ("PPA") dated 08.09.2008 executed between Maharashtra State Electricity Distribution Company Limited and Adani Power Maharashtra Limited for appropriate adjustment in tariff due to "Change in Law" which substantially affected cost and the revenues of the project.

- **MA NO. 11 of 2014 in Case No. 163 of 2014**

Adani Power Maharashtra Limited has submitted Miscellaneous Application in Case No. 163 of 2014 under section 94 (2) of the Electricity Act, 2003 for seeking relief in terms of interest on the amount claimed in respect of the Change in Law events.

The main prayers of this Miscellaneous Application are as under:-

"a) Direct the Respondents to pay interest @ SBI PLR plus 2% from the date of applicability of the respective Change in Law events claimed in the petition.

b) Pass any other orders as this Hon'ble Commission may deem fit and proper."
