Subject: Petition of Ali Akbar Adamji Peerbhoy had provided electricity with own expenses for Matheran Hill Station in 1915 during British rules, as proved under government documents of 1914 and 1915, then the report of development of Matheran is drafted, under Ref. No. 283-B dt.12.05.2015 and in the matter of petition for seeking Royalty-Compensation and Subsidy (Ele.Connection No.026510353748 and 0265100139004).

- **Case No. 210 of 2014**

Ali Akbar Adamji Peerbhoy has submitted a Petition under affidavit on 13.11.2014 for seeking Royalty-Compensation and Subsidy (Electricity Connection No.026510353748 and 0265100139004).

The main prayers of the Petitioner are as under-

*“a) We request the Hon’ble Merc Mumbai considering the devotion and sacrifice of the grandfather of the Petitioner that, we required our rights, which is my Fundamental Right, it is Original resident of Abdul Husein Adamji Peerbhoy at Khatija Lodge, Plot No. 192, City Survey No. 25, Lord Elphinston Road, Matheran who is grandfather of the Petitioner, my two connections of MSEDDB i.e. Residential No. 026510353748 and non domestic No. 026510013904 are there, MSEDDB Co. should pass 75% concession or subsidy for us under said both connections, considering our devotion and sacrifice forever, which we deserve.*

*b) We have spent our own Rs. 1,39,000/- for infrastructure for Matheran 100 years back and accommodated the Indian people at Matheran with constructing the 54 bungalows, due to which, the net value of Matheran Hill Station became Popular, we have devoted all the same during British Raj and the map of Matheran is there in all over the world due to our said devotion today, and Late Abdul Husein Adamji Peerbhoy only should get its credit. Myself Mr. Ali Akbar Adamji Peerbhoy, Petitioner, should get Royalty / compensation amount due to the said devotions, as my one of the Fundamental Rights and we are asking the Hon’ble Merc for the said proposal and Mr. Ali Akbar Adamji Peerbhoy as his heir should get royalty or compensation as a Homage to my late grandfather after 100 years.*

*c) Please direct the Respondents not to disconnect our connection No. 026510353748 and 026510013904 on passing order and injunction order and for final hearing of our present petition.”*

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
