- 3) To direct MSEDCL to pay interest of 9% p.a. from 10.09.2014 (the date of passing order by Hon'ble High Court) till the amount is credited as contravened the direction of Hon'ble MERC in case No. 161 of 2013, by not complying Hon'ble High Court order.
- 4) To direct MSEDCL to compensate petitioner by Rs.1, 00,000/- recovered by way of penalty under Section 142 of Electricity Act 2003.
- 5) To direct MSEDCL to compensate petitioner Rs.1,000/- per day from 10.09.2014 till the order is complied by way of additional penalty under Section 142 of Electricity Act 2003 as Superintending Engineer MSEDCL Akola has contravened the direction of Hon'ble MERC, in case No. 161 of 2013.
- 6) Applicant prays Hon'ble Commission to give any other directives to meet the justice in favour of petitioner."
