Subject: Petition of M/s Shree Balaji Builder and Developers for under Sections 142 of the Electricity Act, 2003 for non-compliance of Order dated 19.07.2014 passed by CGRF, Bhandup (Case No. 541, 542, 543 of 2014)

- **Case No. 213 of 2014**

M/s Shree Balaji Builder and Developers has submitted a Petition under affidavit on 20.11.2014, under Section 142 of the Electricity Act, 2003 against MSEDCL for non compliance of an Order dated 19.07.2014 passed by CGRF, Bhandup in Case No. 541, 542, 543 of 2014.

The main prayers of the Petitioner are as under-

*“1) It is therefore prayed that this petition may kindly be allowed under Section 142 of the Electricity Act 2003 and Respondent be directed to strict compliance of Order dated 19.07.2014 passed by CGRF, Bhandup in grievance No. Case No. 541, 542, 543 of 2014.*

*2) The Respondent be directed to pay Rs. 1000/- per day fine amount from 08.08.2014 to till compliance of Order dated 19.07.2014 passed by CGRF, Bhandup in grievance No. 541, 542, 543 of 2014.*

*3) Cost of Petition and any other relief for which the petitioner is entitled may be granted.”*
