M/s. Pragati Enterprises has submitted a Petition under affidavit on 20.11.2014, under Section 142 of the Electricity Act, 2003 against MSEDCL for non compliance of Order dated 12.08.2014 passed by IGRC, & Order dated 08.10.2014 passed by CGRF Kalyan in Case No. K / N / 0131 / 989 / 2014-15.

The main prayers of the Petitioner are as under-

*“1) It is therefore prayed that this petition may kindly be allowed under Section 142 of the Electricity Act 2003 and Respondent be directed to strict compliance of Order dated 12.08.2014 and endorsing the order of IGRC, CGRF, Kalyan order in grievance No. K / N / 0131 / 989 / 2014 -15.*

*2) The Respondent be directed to pay Rs. 1000/- per day fine amount from 12.08.2014 to till compliance of Order for non compliance of Order of IGRC & CGRF orders.*

*3) Cost of Petition and any other relief for which the petitioner is entitled may be granted.”*
