Subject: Petition of M/s. Shri Shrihari Textiles for under Sections 142 of the Electricity Act, 2003 for non-compliance of Interim Order dated 25.07.2013 passed by CGRF, Kolhapur (Consumer Complaint No.21 of 13-14)

- **Case No. 215 of 2014**

M/s. Shri Shrihari Textiles has submitted a Petition under affidavit on 18.11.2014, under Section 142 of the Electricity Act, 2003 against MSEDCL for non compliance of Interim Order dated 25.07.2013 passed by CGRF, Kolhapur (Consumer Complaint No.21 of 13-14).

The main prayers of the Petitioner are as under-

क) अपेलंट यांना नुकसान भरपाई पोटी रु. १,७३,७५७/- ची नुकसान भरपाई देणेत यावी.

इ) कारणपरत्वे दुरुस्ती करणेस परवानगी मिळावी.

फ) इतर योग्य ते न्यायाचे हुकूम अपिलंटवतीने करणेत यावेत.
