Subject: Petition of Bajaj Finserv Limited Complaint against MSEDCL for non compliance of MERC's Order in Case No. 106 of 2014, Wind Power Tariff Order 2003 and Case No. 59 of 2012 and allegedly holding OA permissions to generator Bajaj Finserve Ltd.(BFS) to wheel wind energy to third party for the period earlier to the date of DOA 2014 and indirect disposal of banked energy to other consumers on chargeable basis and not passing proceeds to generator and causing financially serious losses to BFS.

Bajaj Finserv Limited has submitted a Petition under affidavit on 21.11.2014 under Sections 142 of the Electricity Act, 2003 for seeking relief for non compliance of MERC's Order in Case No. 106 of 2014, Wind Power Tariff Order 2003 and Case No. 59 of 2012 and allegedly holding OA permissions to generator Bajaj Finserve Ltd.(BFS) to wheel wind energy to third party for the period earlier to the date of DOA 2014 and indirect disposal of banked energy to other consumers on chargeable basis and not passing proceeds to generator and causing financially serious losses to BFS.

The main prayers of the Petitioner are as under-

"Hon'ble Commission is humbly requested:

- 1) Direct MSEDCL to issue OA permission to BFS to adjust, banked wind energy (7270092 units) generated from five projects viz. Dvp No 4024, 4065, 4236, 1003, 1006 during April and May 2014 to eligible and established third party M/s Mukand Ltd for FY 2014 15 for the same five projects.
- 2) Direct MSEDCL to install correct meter in place of existing main meter of wind OA consumer at consumer's cost as per CEA Metering Regulation 2010 without compelling installation of standby metering for eligibility to become OA consumer of wind energy.
- 3) Stop MSEDCL from illegal practice of insisting replacement of existing Current and Potential Transformers at consumer's cost if appropriate and not faulty, however working satisfactorily, meeting requirement of accuracy class, turn ratio etc., to continue wind OA and direct MSEDCL to follow CEA's metering Regulation 2010 applicable to existing consumer.
- 4) Non firm energy generator BFS should continue to be allowed to apply to MSEDCL for OA to sale energy to third party.
- 5) Action may please be initiated against respondent U/s 142 of EA 2003 for not obeying Hon'ble Commission's order issued vide in Case No. 106 of 2014, Case No. 59 of 2012 and WPTO 2003.
