

**NOTICE**

Subject: Petition of S. K. Shivaraj & 08 Others for breach of Commission's Order dated 20.08.2014 passed in Case No. 95 of 2014 and provisions of Citizen Charter.

- **Case No. 223 of 2014**

S. K. Shivaraj & 08 others has submitted a Petition through S. K. Parik (authorized representative) under affidavit on 17.12.2014, under Sections 42, 142 and 146 of the Electricity Act, 2003 and Regulations 92 to 94 of MERC(Conduct of Business) Regulations, 2004 for seeking relief due to breach of Hon'ble Commission's Order dated 20.08.2014 passed in Case No. 95 of 2014 and breach of provisions of Citizen Charter by MSEDCL.

The main prayers of the Petitioner are as under-

*"a) The Respondent No. 1 be directed to grant Open Access permission in favour of Respondent No. 2 to purchase energy generated by the Petitioners for the period from 01.04.2014 to 31.03.2015.*

*b) That heavy penalty be imposed upon Respondent No.1 for willful breach of the orders of this Hon'ble Commission.*

*c) All other just and equitable reliefs be granted to the petitioner for the effective adjudication of this case."*
