Subject: Petition of M/s. Arihant Universal Realty Pvt. Ltd. for Review Petition regarding
MERC order dated 03.12.2014 in MERC case No. 134 of 2014.

- **Case No. 31 of 2015**

M/s. Arihant Universal Realty Pvt. Ltd. has submitted a Petition under affidavit on 19.01.2015, under Sections 142 & 146 of the Electricity Act, 2003 and Regulation 85 of the MERC (Conduct of the Business) Regulations 2004 for Review of the MERC order dated 03.12.2014 in MERC case No. 134 of 2014.

The main prayers of the Petitioner are as under-

"A) Please issue notice to MSEDCL to M/s. CIDCO ltd. to appear before Hon'ble MERC in above review petition.

B) Please call the complete records of above case from MSEDCL & CIDCO ltd.

C) Please direct MSEDCL to refund us the cost of electrical infrastructure amounting Rs. 4528021/- with interest as per RBI rules as per section 62(6) of E.A. 2003.

D) Please direct M/s. CIDCO to refund us the PSIDC charges of Rs. 2915551/- with 12% interest per annum.

E) Please take stern action against concerned officers of MSEDCL as section 142 & 146 of E.A. 2003 & MERC (SOP) regulation – 2005.

OR

F) In the alternative, the Hon'ble MERC may please remand this matter to CGRF bhandup for detail verification, hearing & appropriate order as per law.

3. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 28 May, 2015 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
