Subject: Petition of M/s. M. R. Scion Agro under Sections u/s 142 of the Electricity Act, 2003 for non - compliance of Order dated 28.11.2013 passed by CGRF, Kolhapur in Consumer Complaint No.14/18/19/2013-14.

- **Case No. 32 of 2015**

M/s. M. R. Scion Agro has submitted a Petition under affidavit on 21.01.2015, under Sections 142 of the Electricity Act, 2003 and Regulation 22 of the MERC (CGRF & Electricity Ombudsman) Regulations 2006 for non-compliance of Order dated 28.11.2013 passed by CGRF, Kolhapur in Consumer Complaint No.14/18/19/2013-14.

The main prayers of the Petitioner are as under-

४)- जरूर भासल्यास याचिकेत योग्य ती दुरुस्तीस परवानगी असावी ही विनंती.
