Subject: Petition of M/s. Shri Sant Gadgebaba Sahakari Sut Girni Ltd., non-compliance by Superintending Engineer, MSEDCL, Akola of an Order No. CGRF / Akola / AMZ / 426 dt. 13.03.2014 in complaint No. 105 / 2013 passed by CGRF, MSEDCL, Amravati Zone, Akola read with Regulation 22 and 8.7 of MERC CGRF Ombudsman Regulation 2006 under Sections 142, 146 and 149 of the Electricity Act, 2003.

- **Case No. 33 of 2015**

M/s. Shri Sant Gadgebaba Sahakari Sut Girni Ltd. Akola has submitted a Petition under affidavit on 16.02.2015, under Sections 142, 146 and 149 of the Electricity Act, 2003 and Regulation 22 and 8.7 of the MERC (CGRF & Electricity Ombudsman) Regulations 2006 for non-compliance by Superintending Engineer, MSEDCL, Akola of an Order No. CGRF / Akola / AMZ / 426 dt. 13.03.2014 in complaint No. 105 / 2013 passed by CGRF, MSEDCL, Amravati Zone, Akola.

The main prayers of the Petitioner are as under-

*"Petitioner prays Hon'ble Commission-*

*1) To direct MSEDCL to comply the order passed by Consumer Grievance Redressal Forum, Akola Zone in complaint No. 105/2013 dated 13.03.2014 immediately in ensuing bill.*

*2) To initiate action against guilty officers of MSEDCL, Akola under Section 142, Section 146 and Section 149 of Electricity Act, 2003.*

*3) To direct MSEDCL to compensate the petitioner by Rs. One Lakh recovered by way of penalty under Section 142 of E.A. Act, 2003.*

*4) To direct MSEDCL to pay Rs.15,000/- towards the cost of this petition.*

*5) Applicant prays Hon'ble Commission to give any other directives to meet the justice in favour of petitioner.*
