d) To direct MSEDCL to pay the interest on the refund amounts at the rate as may be fixed by this Hon'ble Commission in a time period to be fixed by this Hon'ble Commission;

e) The Hon'ble Commission be pleased to rule that in future after the issuance of new Tariff Orders in case MSEDCL fail to accord approval beyond 7 days from date of submission of request from Samrudh Pharmaceuticals Pvt. Ltd.(Consumer No. -003019018155) to exercise its option of type of supply then the consumer shall be automatically entitled to have been granted such approval from 8th day onwards.

f) This Hon'ble Commission be pleased to expedite hearing and final disposal of this Petition."
