Subject: Petition of Abhijeet MADC Nagpur Energy Pvt Limited Review Petition under Section 94 (1) (f) of the Electricity Act and Regulations 85 (a) of MERC (Conduct of Business) Regulations, 2004.

- **Case No. 46 of 2015**

Abhijeet MADC Nagpur Energy Pvt. Ltd. has submitted a Petition under affidavit on 30.03.2015 under Section 94 (1) (f) of the Electricity Act, 2003 and Regulation 85 (a) of MERC (Conduct of Business) Regulations 2004 for review of Order dated 20.01.2015 passed by MERC in Case No. 149 of 2014.

The main prayers of the Petitioner are as under-

“i) To admit the petition for review of the Hon’ble Commission’s order passed on 20th January 2015 in Case No. 149 of 2014,

ii) To fix the hearing in the case on urgent basis, in view of the facts and circumstances of the matter,

iii) To suitably modify and / or amend the order passed on 20th January 2015 in Case No. 149 of 2014, exempting the Petitioner from the requirement of filing a separate petition for fixation of the transmission charges,

iv) To condone the delay in filing of the review petition in view of the facts and circumstances of the case.

v) To approve the transmission tariff of Rs. 0.46 / unit, being the same rate as duly approved by the Hon’ble Commission for MSETCL in Case No. 123 of 2014, for the use of AMNEPL’s system by MSEDCL and MADC.

vi) To approve the interim payment of the said charges at the rate of Rs. 0.40 / unit which is lower than the tariff duly approved by the Hon’ble Commission in Case No. 123 of 2014, till finalization of the matter,

vii) To direct MSEDCL to release interim payment towards the utilization of AMNEPL’s lines @ Rs. 0.40 / unit, for the provisional bill raised by the Petitioner, till the disposal of the present petition,

viii) To direct MADC to regularly pay transmission charges @ Rs. 0.40 / unit, on an interim basis, towards the provisional bills raised by the Petitioner, till the disposal of the present petition,

ix) Condone any inadvertent omissions / errors / shortcomings and permit Petitioner to add / change / modify / alter this filing and make further submissions as may be required in future.

x) Pass any other order that the Hon’ble Commission may deem fit and just under the facts and circumstances of the case.”
