

NOTICE

Subject: Petition of The Tata Power Company Limited for approval of protocol to enable consumer to select to any Electricity Distribution network in Mumbai as per judgement of the Appellate Tribunal for Electricity dated 28 November, 2014.

- **Case No. 40 of 2015**

The Tata Power Company Limited has submitted a Petition under affidavit on 11.03.2015 for approval of protocol to enable consumer to select to any Electricity Distribution network in Mumbai as per judgement of the Hon'ble Appellate Tribunal for Electricity dated 28th November, 2014.

The main prayers of the Petitioner are as under-

“In view of the aforesaid facts and circumstances, it is most respectfully prayed that this Hon'ble Commission may be pleased to:

a. Approve the proposed protocol as described in Section V of the instant petition with such modifications as the Hon'ble Commission may deem necessary.

b. Consider an early hearing on the submitted petition so as all concerned parties can share their suggestions and apprehensions if any in due time. The protocol then can be revised accordingly and Tata Power-D, before arrival of monsoon season, can start procedures to extend its distribution network to the consumers who have opted for Tata Power –D as their preferred licensee.

c. Issue appropriate directives to all distribution licensees in Mumbai region to ensure that all the principles described in the protocol are adhered to and consumers can avail their preferred network in a hassle free manner.

d. Condone any shortcomings in the Petition and allow the Petitioner to submit further submissions as may be required by the Hon'ble Commission.

e. Pass any other such directive as that the Hon'ble Commission may deem appropriate in the facts and circumstances of the case.”
