Subject: Review Petition of Mumbai International Airport Pvt. Limited under Section 94 (1) (f) of the Electricity Act, 2003 read with Regulation 85 (a) of the MERC (conduct of business) Regulations, 2004 on behalf of the Mumbai International Airport Pvt. Ltd. against the order dated 26<sup>th</sup> June 2015 passed in Case No. 18 of 2015.

- **Case No. 103 of 2015**

Mumbai International Airport Pvt. Ltd. has submitted a Petition under affidavit on 03.08.2015 under Section 94 (1) (f) of the Electricity Act, 2003 & Regulation 85 (a) of the MERC (conduct of business) Regulations, 2004 for seeking Review of the order dated 26<sup>th</sup> June 2015 passed in Case No. 18 of 2015.

*b) Grant ex-parte interim / ad-interim orders and / or directions in terms of prayer (a) above staying the operation of the impugned order against the Review Petitioner;*

*c) Pass such other order or orders as it may deem fit and proper in the circumstances of the case.”*
