Subject: Interim Application of Shri Ashish Subhas Chandrana in Review Petition of MSEDCL, in the matter of To review Order dated 26.06.2015 passed by the Hon'ble Commission in Case No 121 of 2014 registered as Case No 94 of 2015.

- **MA No 05 of 2015 in Case No. 94 of 2015**

Ashish Subhas Chandrana Individual Consumer Representative appointed by MERC has submitted Interim Application in MERC Case No. 94 of 2015 under affidavit on 04.08.2015 under Regulation 81 of MERC (Conduct of Business Regulation) 2004 for seeking ad-interim relief.

A) The main prayers of this Interim Application are as under:-

“a) In Order to oppose the Review Petition filed by MSEDCL in capacity of consumer Representative appointed by Hon'ble Commission, I seek the following documents for which Petitioner may please be directed to provide the same.

b) Set of annexure referred in present petition vide para 3.2 of review petition no 94 of 2015 which are not provided by Petitioner MSEDCL.

c) Application of all consumers who applied for HT-1 C to HT-1 N in entire Maharashtra and including each and every circle office of MSEDCL and reply, sanction, rejection what so ever of the nature of document given to such complainant.

a) Copy of SLP (CIVIL) No. 1911 of 2015 filed by MSEDCL before Supreme Court.

b) Minutes of the meetings of recovery committee referred in petition since 1st of April 2006 to till today along with copy of all applications considered in the meetings and approval letters issued based on the said meetings.

c) Details of credit given to all consumers in the state of Maharashtra for giving retrospective approval of change of tariff from HT-1 C to HT-1 N including to Jindal Photo film of Nashik Zone without any Order of CGRF, Ombudsman, High Court on any other Judicial body including consumer forum.

d) List of All Consumers along with amount credited on account of MERC order in case no 88 of 2012 order dated 16 July 2013 and copy of petition received in the said matter along with all documents and reply filed by MSEDCL including all citations if any.

h) *All documents pertaining to govt. audit objection referred by DOP at Aurangabad Public Hearing of case no 121 of 2014 on the issue of tariff change from continuous to non continuous and all compliances and letters and correspondences made by MSEDCL in this respect.*

i) *Copy of permission of MSEB holding company Ltd for filing present review petition read with resolution of Holding Company published by "Dainaik Salal"*

j) *Any other document which applicant may require during the pendency of present proceeding after receipt of above started documents.*
