Subject: Petition of Adani Power Maharashtra Limited under Section 86, 94 (1) (f) and (g) of the Electricity Act, 2003 read with Regulation 92, 93,94 and 95 of the MERC (Conduct Of Business) Regulations, 2004 in regard to clarification on netting of entire 520 MW in each block instead of allowing compensation for 800 MW from Lohara coal block by this Hon'ble Commission in order dated 05.05.2014 in Case No 63 of 2014 for supply of 800 MW from Tiroda Thermal Power Station.

- **Case No. 28 of 2015**

Adani Power Maharashtra Ltd. has submitted a amended Petition alongwith an application for amendment of Petition under affidavit on 15.09.2015 under Section 86, 94 (1) (f) and (g) of the Electricity Act, 2003 & Regulation 92, 93, 94 and 95 of MERC (Conduct of Business) Regulations, 2004 for seeking clarification on netting of entire 520 MW in each block instead of allowing compensation for 800 MW from Lohara coal block by this Hon'ble Commission in order dated 05.05.2014 in Case No 63 of 2014 for supply of 800 MW from Tiroda Thermal Power Station.

A) The main prayers of the Petitioner in amended Petition are as under-

"In view thereof, the Petitioner respectfully prays that

a) this Hon'ble Commission may kindly be pleased to clarify that the quantum to be considered as per the methodology suggested at Para 151 of the Order dated 21.08.2013 in Petition No. 68 of 2012 corresponds to the obligation of the petitioner to supply under PPA, which is equivalent to 416 MW as detailed in Para 8(a) herein above.

b) Pass any other Order or Orders as this Hon'ble Commission may deem fit and proper."

B) The main prayers of the Petitioner in an application for amendment of Petition in Case No. 28 of 2015 are as under-

a) allow the Petitioner to amend the present petition in the manner detailed in paragraph 4 of the present application and take on record the amended petition being Annexure A hereto;

b) Pass any such other order as this Hon'ble Commission may deem fit and proper."

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 23 September, 2015 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
