Subject: Petition filed by Power Exchange India Limited under Sections 30, 42, 66, 86 (1) (c) & (k) of the Electricity Act, 2003 & Regulation 32 of MERC (Conduct of Business) Regulations, 2004 & Regulation 42, 43 & 44.5 of MERC (Distribution Open Access) Regulations, 2014 for allowing Power Exchange India Limited to commence and operate intra-state power market in the State of Maharashtra.

- **Case No. 115 of 2015**

Power Exchange India Limited has submitted a Petition under affidavit on 08.09.2015 under Sections 30, 42, 66, 86 (1) (c) & (k) of the Electricity Act, 2003 & Regulation 32 of MERC (Conduct of Business) Regulations, 2004 & Regulation 42, 43 & 44.5 of MERC (Distribution Open Access) Regulations, 2014 for allowing Power Exchange India Limited to commence and operate intra-state power market in the State of Maharashtra.

The main prayers of the Petitioner are as under-

“In view of the aforesaid facts, circumstances and submissions, it is humbly and respectfully prayed that the Hon’ble Commission may kindly be pleased :

- a) *to allow the Petitioner to commence and operate intra-state power market in the State of Maharashtra based on the provisions of the PMR, Rules, Bye-Laws and Business Rules of the Petitioner as approved by the Hon’ble CERC from time to time.*
- b) *to allow the Petitioner to launch the proposed product / contract for the intra-state market in the State of Maharashtra;*
- c) *to modify, amend, relax or remove the difficult in giving effect to the provisions of the Maharashtra Electricity Regulatory Commission (Distribution Open Access) Regulation, 2014 with respect to the Petitioner.*
- d) *to pass such other order(s) as the Hon’ble Commission deems fit and proper.”*
