- c) That this Hon'ble Commission be pleased to re-determine actual distribution losses of RInfra –D system for FY 2012-13 based on MSLDC certification of T<>D interface drawl of RInfra-D and re-compute the efficiency loss / gain thereon;
- d) That this Hon'ble Commission be pleased to allow RInfra –D to recover the adjustment, from consumers through the FAC mechanism, in order to prevent un-necessary accumulation of carrying cost on the same.
- e) Pass any Order(s) as this Hon'ble Commission may deem fit in the facts & circumstances of the Present case."
