- 2) Circular No. 222 dt. 31.10.2015 regarding FAC should be straightway cancelled/scraped/set aside, as it is against the MOD directions of the Commission given in the Tariff Order dt.26.06.2015. The first FAC should be applied only after due vetting by the Commission is done. Thenafter also regular bimonthly vetting should be done by the Commission regularly and within 1 or 2 months time frame without any delay.
- 3) Any demands against the MOD principles should be straightway rejected and necessary directions should be issued, so as to adhere to the orders of the Commission scrupulously.
- 4) Any other necessary / concerned directions should be issued by the Honourable Commission, as it may think fit & proper.
