

NOTICE

Subject: Application of MSEDCL for Grant of Distribution Licence in the Mumbai City and Part of Mumbai Suburban Area

- **Case No. 87 of 2014**

The Petitioner was directed as follows during TVS dated 23 April, 2014:-

“The applicant requested the Commission some more time to present its network roll out plan as they have requested TPC for data, which is awaited.

The Commission directed the applicant that the network roll out plan should demonstrate its commitment towards non cherry picking of the consumers.

The Commission also directed the applicant to submit all the replies to the following:

a. Data gaps identified and communicated to the applicant before TVS and

b. Queries raised during both the TVS of 17.04.2014 and 23.04.2014

The replies to the data gaps and queries should be accompanied with the draft of duly filled Public Notice for approval of the Commission. After necessary prudence check, the application shall be processed for admission and subsequent public hearing. ”

With reference to the above, I am directed to bring to the notice of the Petitioner the following facts:-

- i. In spite of follow up from the Commission's Office, the Petitioner has not complied with the directions given by the Commission during TVS dated 23 April, 2014 and hence, the present Application is incomplete.
- ii. The Petitioner has not submitted duly filled Public Notice, Code of Conduct Certificate and additional submissions like network rollout plan in its Licence Application.
- iii. There is no response from the Petitioner in spite of sufficient opportunities and time given for making revised submissions.

In view of above, I am directed to communicate that the Commission will hear the Petitioner on 'why the licence application in Case No 87 of 2014, which is incomplete and not fulfilling the requirements under MERC (Distribution Licence Conditions Regulations) 2006, should not be dismissed as not admissible'.

The above said hearing will be held on **Wednesday, 09 December, 2015 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.
