The Seafood Exporters Association of India has submitted a Miscellaneous Application under affidavit on 28.12.2015 under Sections 142 & 146 of the Electricity Act, 2003 r/w sections 62, 64, 86 (1) (A) of the Electricity Act, 2003 for seeking urgent Orders against MSEDCL for violation of Daily Order dated 24.11.2015 passed by MERC in Case No. 42 of 2015.

The main prayers of the Petitioner are as under-

"In view of the aforesaid contemptuous conduct of Respondent No.1 and predicaments which are being faced by the members of the Petitioner, it is prayed as under:

- a) that it may be held that Respondents No. 1 and 2 are guilty of contempt for willfully, knowingly and deliberately acting in contravention and contrary to the Order dated November 24, 2015 in Case No. 42 of 2015 passed by this Hon'ble Commission;
- b) The action of the Respondent No. 1 and 2 be intimated to / procedure adopted for this Hon'ble High Court, Bombay deemed fit and proper for initiating the contempt procedure in respect of the contempt committed by them of the Order dated November 24, 2015 in Case No. 42 of 2015 passed by this Hon'ble Commission;
- c) pending the hearing and final disposal of this Contempt Petition the Respondent No. 1 and 2 be directed to forthwith purge the contempt of the Order dated November 24, 2015 in Case No. 42 of 2015 by holding in abeyance and withdrawing the demands and bills being Exhibit C to F issued to the Members of the Petitioner Association;
- *d) ad-interim relief in terms of prayer clause (c) above;*
- *e)* The cost of this Petition be provided for;
- *f)* Such further orders as this Hon'ble Court may deem fit and proper be passed in favour of the Petitioner."
