

**NOTICE**

Subject: Suo motu proceeding on Committee Report submitted by CE (STU) in compliance to directives given in Order in Case No 172 of 2014 for recommendation and a protocol on idle capacity and apportionment and commercial settlement of Tata Power's Trombay Unit 6.

- **Case No. 133 of 2015**

1. The Commission has issued an Order dated 19 March, 2015 in Case No. 172 of 2014 on the Petition filed by Tata Power Company- Generation Business for recovery of variable charges of its Unit 6 from RInfra - D. The Commission directed to form a Committee chaired by Chairman & MD of MSETCL as STU to submit a protocol, which may include resort to idle Capacity and apportionment of commercial settlement of TPC-G Unit 6.

The relevant extract is reproduced below:-

*"...21. The Commission directs that a Committee make recommendations for such a protocol, which may include resort to idle capacity and on related issues of apportionment and commercial settlement. The Committee shall be chaired by the Chairman-cum-Managing Director of the MSETCL as STU, and include empowered representatives of MSLDC, MSEDCL, BEST, RInfra-D, TPC-D and TPC-G. The Committee shall submit its report within 3 weeks, following which the Commission will decide the further course of action."*

2. In accordance to the powers vested under Regulation 83 of MERC (Conduct of Business) Regulation 2004, if the report or information obtained in accordance with Regulation 82 above or any part thereof is proposed to be relied upon by the Commission for forming its opinion or view in any proceedings, the parties to the proceedings shall be given a reasonable opportunity for filing objections and making submissions on such report or information.
3. Since the Commission is in receipt of the Report of the above said Committee, I am directed to communicate that the hearing in the above matter will be held in the presence of authorised consumer representatives on **Thursday, 21 January, 2016 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The parties are directed to submit their say on affidavit, if any, on the above mentioned Report (enclosed herewith) with a copy to the parties and authorised consumer representatives.
