Subject: Petition for M/s. Gujarat Ambuja Exports Limited for punishment under Section 146 of Electricity Act 2003, for non - compliance of Order dated 16.09.2015 passed by CGRF, Amravati Zone, Akola in complaint No. 67 of 2009.

- **Case No. 02 of 2016**

M/s. Gujarat Ambuja Exports Limited has submitted a Petition under affidavit on 29.12.2015 under Section 146 of the Electricity Act, 2003 for seeking action against Respondents for non-compliance of Order dated 16.09.2015 passed by CGRF, Amravati Zone, Akola in complaint No. 67 of 2009.

The main prayers of the Petitioner are as under-

“It is therefore most humbly prayed that;

- 1) *Petition may kindly be allowed.*
- 2) *Respondents be tried for the acts committed by them and they be punished as provided under the Act for noncompliance with the orders and directions dated 16.09.2015 passed by Forum, Akola in Complaint No. 67 of 2009, for committing contempt of court.*
- 3) *By way of affirmative action / direction Respondents be directed to comply with the order.*
- 4) *Respondents be convicted for the offences committed and after conviction, if there is continuing failure on their part, additional fine as provided under Electricity Act, 2003 and Regulation be imposed and levied on both Respondents.*
- 5) *Any other suitable relief or order which this Hon’ble Commission deems fit and proper under the facts and circumstances of the matter may kindly be passed against Respondents and in favour of Petitioner.”*

3. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 15 March, 2016 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

5. The Respondents are directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
