Suggestions/Objections on Maharashtra State Load Despatch Centre's (MSLDC) Petition for approval of Truing up of Budget Cost of Operations for FY 2014-15, Provisional truing-up for FY 2015-16 and ARR forecast and determination of Fees and Charges for FY 2016-17 to FY 2019-20 (Case No. 20 of 2016)

 Maharashtra State Load Despatch Centre (MSLDC) has filed a Petition for approval of Truing up of Budget Cost of Operations for FY 2014-15, Provisional truing-up for FY 2015-16 and ARR forecast and determination of Fees and Charges for FY 2016-17 to FY 2019-20 with reference to Section 32 of the Electricity Act, 2003.

The present filing for the truing-up for FY 2014-15 and for the provisional truing up for FY 2015-16 is based on applicable provisions of the MERC (Multi Year Tariff) Regulations, 2011 (the MYT Regulations, 2011), previous Orders of the Commission on MSLDC's Operating and Capital Charges and Regulation 18.9 of the MERC (Transmission Open Access) Regulations, 2014 (the Transmission OA Regulations). Filing for each year of the Control Period from FY 2016-17 to FY 2019-20 is based on applicable provisions of the MERC (Multi Year Tariff) Regulations, 2015 (the MYT Regulations, 2015) and other relevant Regulations.

- 2. The Commission has admitted the Petition on 10th March, 2016 and directed MSLDC to publish a Public Notice under Section 64(2) of the Electricity Act, 2003 for inviting suggestions/objections from the Public through this Notice.
