2. The petition no. 17 of 2015 filed by MSEDCL for approval of CSS for the period from Sept-2013 to Feb-2104 should not be considered on the reasons mentioned above.

3. In our case additional CSS recovered at Rs.1.12/unit over and above the normal CSS is not justifiable and APTEL vide its order dt. 11.09.2014 for case no.65/2014 set aside impugned order dt.19.10.2013. As per this order of APTEL, we have filed our claim for refund of additional CSS amount which has been collected illegally. The MSEDCL may be asked to refund our additional CSS amount along with the accrued interest for the above period.
4. To permit us to make further submission, addition & alteration in this intervening petition as may be required from time to time.
5. To condone any error/omission and give us opportunity to rectify the same during the course of proceedings.
6. To pass any such order by Hon. Commission which may be in the interest of consumer & justice by safeguarding rights of the consumers.

5. The MSEDCL is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
