Subject: Petition filed by Shri Subhash Ananda Tambe & 3 Others, in the matter of the Order passed by the Sub-Divisional Officer Pune, (under the powers delegated by District Collector), on 27<sup>th</sup> June 2016 under the provisions of Sec. 16 of Indian Telegraph Act 1885. in the terms of the Order of the Honorable High Court of Bombay in Writ Petition No. 7985 of 2016 Dated 14.09.2016 & Revision under Rule 3(3) of Maharashtra Electricity Works of Licensees Rules, 2012.

- **Case No. 126 of 2016**

Shri Subhash Ananda Tambe & 3 Others have submitted a Petition under affidavit on 23.09.2016 the present Revision Petition under Rule 3(3) of Maharashtra Electricity Works of Licensees Rules, 2012 against the Orders passed by the Respondent 2 who is Sub-Divisional Officer-Pune delegated power by the District Magistrate. The Honorable High Court while disposing the Appeal No. 7985 of 2016 by Order dated 14.09.2016 has allowed the Petitioner to withdraw the Writ Petition with liberty to approach the Commission and Stay Order is granted for 2 weeks for enabling the Petitioner to apply for Interim Order before the Commission and accordingly the Petitioners have filed the said Petition for following reliefs:

- a) *The Appeal be allowed in toto.*
- b) *The orders of Respondent No. 2 passed below Case No. MG/KaVi/118/16, Dt. 27th June 2016 be declared to be a nullity and quashed and set aside.*
- c) *Respondents No. No. 3 and 4 be directed to follow the Approved rout, the map of which obtained by the Petitioners from Respondent No. 2 under RTI Act is filed on record by the Petitioners at "Annexure J".*
- d) *Respondents No. No. 3 and 4 be directed not to deviate from the Route Approved.*
- e) *Respondents No. 3 and 4 be restrained by an interim injunction from constructing the disputed Extra High Voltage Transmission Line in the lands of the Petitioners during the pendency of the Appeal.*
- f) *Ad-interim Injunction in terms of prayer (e) above.*
- g) *Respondents No. 3 and 4 be directed to pay compensatory costs of Rs.1,00,000/- to the Petitioners.*
- h) *For costs of the Appeal from the Respondents.*
- i) *For other just and equitable orders the Honorable Authority may deem fit in the interest of justice.*
