The Petitioner is engaged in the Wind power generation and has entered into various WEPAs with the Respondent MSEDCL for the sale of power generated by its projects in the State of Maharashtra. The Applicant has filed the Petition requesting to direct MSEDCL to make payment towards outstanding invoices as well as delayed payment charges as claimed by the Petitioner. It is prayed to:

- a) Direct MSEDCL to make payment of the Outstanding Amount towards Sales Invoices due from November 2015 for the projects situated at Dhule, Nandurbar and Nashik and from September 2015 for the projects situated at Sangli till date within seven (7) days [a sum of Rs. 4,46,40,131 (Rupees Four Crores Forty Six Lacs Forty Thousand One Hundred Thirty One Only) is outstanding towards invoices for the projects situated at Dhule, Nandurbar, Nashik and Sangli, respectively as on October 26, 2016 as detailed in **Annex "F"**];
- b) Direct MSEDCL to make payment of the Outstanding Amount towards DPC as per the WEPAs [a sum of Rs. 52,34,526(Rupees Fifty Two Lacs Thirty Four Thousand Five Hundred Twenty Six Only) is outstanding DPC for the projects situated at Dhule, Nandurbar, Nashik and Sangli, respectively as on October 26, 2016 is also detailed in Annex F];
- c) Direct the Respondents to pay carrying cost at the rate of 15% per annum of the delay in payment of the late payment surcharge by the Respondent;
- d) Award costs of these proceedings against MSEDCL and in favour of the Petitioner; and
- e) Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.
