a) Direct MSEDCL to make payment of the Outstanding Amount towards Sales Invoices due from November 2015 for its aforesaid Projects till date within seven (7) days or set off against the electricity bills of the Petitioner due and payable to MSEDCL from the month of November 2015 [a sum of Rs. 7,62,06,877 (Rupees Seven Crores Sixty Two Lakhs Six Thousand Eight Hundred and Seventy Seven Only) outstanding towards invoices for as on October 15, 2016 as detailed in **Annex F**];

b) Direct MSEDCL to make payment of the Outstanding Amount towards DPC as per the WEPAs till date within seven (7) days or set off against the electricity bills of the Petitioner due and payable to MSEDCL from the month of November 2015 [a sum of Rs. 71,92,141.53 (Rupees Seventy One Lakhs Ninety Two Thousand One Hundred Forty One and Fifty Three Paise Only) is outstanding DPC for the aforesaid Projects at Dhule as on October 15, 2016 is also detailed in **Annex F**];

c) Direct the Respondents to pay carrying cost at the rate of 15% per annum of the delay in payment of the late payment surcharge by the Respondent;

d) Award costs of these proceedings against MSEDCL and in favour of the Petitioner; and

e) Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.
