Subject: Revision petition of MSETCL, Under Clause 13(2) Maharashtra Works of Licensee Rules, 2012 read with section 67 of Electricity Act, 2003.

- **Case No. 140 of 2016**

MSETCL has submitted a Petition under affidavit on 25.10.2016. MSETCL has filed this Petition against the Respondents, Dr. Hiralal Ganpatrao Nimbalkar & Ors. on the order dated 26.09.2016 passed by the District Magistrate, Latur. The Petitioner submits that the relief sought by all the Respondents in the original application (under provision of Section 67 of EA, 2003) before the District Magistrate Latur is against provision of law and the application was not maintainable, but the District Magistrate allowed the application of the Respondent and directed the Petitioner to remove the Tower location No.2. by considering fact and circumstances as stated, it is prayed that:

“here in above revision petition of the petitioner may kindly be allowed by set asideing the impugned order under challenge.”

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
