

# Verification and Compliance of Renewable Purchase Obligation targets of Tata Power -D for FY 2015-16

Our point wise response to the queries raised by the Hon'ble Commission regarding RPO Compliance is as follows:

a) TPC-D should verify the RPO settlement details for FY 2015-16, as submitted by MEDA (copy attached as Annexure with this letter) and highlight discrepancies, if any , along with proper justification.

#### Response

We have verified the data submitted by MEDA regarding RPO for FY 2015-16 and brought out the discrepancies in a comparison table provided below:

As seen from Table 1, there are minor discrepancies between the data submitted by MEDA and that of Tata Power-D. The discrepancies are explained further below:

- The difference in Energy Requirement of Tata Power-D at InSTS in FY 2015-16 as compared to MEDA is on account of the fact that
  - a) Changeover Sales have been revised based on the monthly settlement of energy between Tata Power-D and RInfra-D
  - b) Transmission loss figures have been revised based on the revision from MSLDC.

Further, we wish to submit that the energy requirement will be finalized once the final FBSM bills will be issued by MSLDC.

Keeping this in mind, the revised provisional Energy Requirement of Tata Power-D at InSTS in FY 2015-16 is 6020.80 MUs.

- ii) The discrepancy in the RPO targets for Solar, Non-Solar and Mini/Micro Hydro is primarily arising out of discrepancy in the InSTS requirement of Tata Power-D as explained above.
- iii) With respect to the Mini/Micro Hydro RPO achievement, due to the discrepancy in the InSTS requirement of Tata Power-D, the actual Mini/Micro Hydro RPO achieved is only 2.92 MUs against 4.47 Mus submitted earlier and presented by MEDA for the year FY 2015-16.
- b) TPC-D should submit the status of its Solar, non-Solar RPO compliance including Mini-Micro Hydro RPO compliance, as per the directives of the Commission vide Orders in Case No. 182 of 2013, Case No. 192 of 2014 and Case No. 18 of 2016 along with detailed statement for project wise energy procurement in MUs from all RE generating projects and project wise contracted Solar, non-Solar RE power capacity in MW including Mini-Micro Hydro projects, capacity in MW during FY 2010-11 to FY 2014-15.

#### Response

#### Solar RPO Compliance

The Hon'ble Commission, in its Order dated 20<sup>th</sup> December, 2013 in Case No 159 of 2013, had allowed Tata Power-D to meet its Solar Obligation on a cumulative basis upto FY 2015-16. The extract of the Order is as given below:

11. Thus, the Commission hereby relaxes/waives the Solar RPO targets as stipulated under Regulation 7.1 of the MERC (Renewable Purchase Obligation, its compliance and Implementation of REC Framework) Regulations, 2010, for TPC-D for FY 2010-11,FY 2011-12 and FY 2012-13 and directs TPC-D to fulfil the Solar RPO target on a cumulative basis by FY 2015-16.

The cumulative shortfall is as provided below:

As can be seen from Table 2 above, Tata Power-D has met its cumulative Solar RPO target and is now having a surplus of 0.22 MUs. This has been achieved through Tata Power-D's existing contracts including the long term agreement with Tata Power Renewable Energy Ltd. (TPREL) for 25 MW solar power plant at Palaswadi which became operational in FY 2014-15.

#### Non-Solar RPO Compliance

#### FY 2010-11 to FY 2013-14 & FY 2014-15

In case of Non Solar RPO obligation Tata Power-D had already met the cumulative shortfall in the year FY 2013-14 & standalone target for FY 2014-15. The same has been approved by the Hon'ble Commission through its Order in Case 192 of 2014 dated 27<sup>th</sup> April 2015 & in Case 18 of 2015 dated 31<sup>st</sup> August 2016. The extract of the two Orders are as given below:

Case 192 of 2014 dated 27th April 2015

<u>The Commission notes that TPC has fulfilled its Non-Solar RPO targets</u>, but not its Solar RPO and Mini/Micro Hydro Power (within the Non-Solar) RPO targets, for FY

2013-14. <u>TPC has also fulfilled its Non-Solar RPO target by 2013-14, and exceeded its Non-Solar RPO target for FY 2013-14 by 8.56 MUs.</u>

Case 18 of 2015 dated 31st August 2016

As will be seen from the above Table, TPC-D has fulfilled its <u>stand-alone Solar and Non-Solar RPO targets for FY 2014-15</u>, with a surplus of 20.08 MUs and 2.42 MUs <u>respectively</u>, but not the Mini /Micro Hydro Power target (within the Non- Solar RPO), with a stand-alone shortfall of 1.06 MUs. Including past years, at the end of FY 2014-15 TPC-D had a cumulative surplus of 12.18 MUs against its Non- Solar RPO targets, and a cumulative shortfall against its Solar and Mini /Micro Hydro targets of 43.83 MUs and 3.44 MUs, respectively.

#### FY 2015-16

In case of FY 2015-16 the detailed project wise summary of energy procurement in MUs from all Wind Generating Stations including energy procurement through REC is as given below:

As seen from the above Tata Power-D has met the total requirement of Non Solar RE obligation for FY 2015-16 through procurement of RE power to the tune of 298.57 Mus & balance through 212.17 through REC purchase.

### Cumulative shortfall from FY 2010-11 to FY 2014-15 & FY 2015-16

As seen from the above table the opening balance for cumulative shortfall upto FY 2014-15 was 3.45 Mus. In this regard, we wish to submit that, the Hon'ble Commission has in its Order 18 of 2016, dated 31st August 2016 allowed Tata Power-D to purchase Non-Solar RECs in the FY 2016-17 to meet any shortfall remaining for the period till FY 2014-15. Further, Tata Power-D has filed a Review Petition against MYT Tariff Order in Case 47 of 2016 dated 21st October 2016 in which the correction of energy balance for FY 2014-15 has been requested. In view of this Tata Power-D will meet the cumulative short fall in its Mini/Micro Hydro RPO compliance shortfall till FY 2014-15 through purchase on Non-Solar RECs during the year FY 2016-17. The extract of the Order 18 of 2016 is reproduced below:

The Commission had earlier allowed TPC-D, in Case No. 192 of 2014, to meet its cumulative Mini/Micro Hydro RPO shortfall upto FY 2013-14 by FY 2015-16. Neither this shortfall nor the stand-alone target were met in FY 2014-15 for the reasons cited in these proceedings. In the light of the above discussion and its powers of relaxation and removal of difficulties under Regulations 18 and 20 of the RPO Regulations, 2010, the Commission now allows TPC-D to purchase Non-Solar RECs in the current year (FY 2016-17) to meet any shortfall still remaining for the period upto FY 2014-15. The performance of TPC-D in respect of FY 2015-16, which is now over, is not before the Commission, and will be reviewed in the next verification proceedings.

Further, Tata Power -D has surplus REC 1.89 Mus after fulfilling its RPO obligation of 1.02 Mus towards FY 2015-16. This surplus will be utilized for meeting the cumulative shortfall of Mini Micro obligation on cumulative basis.

- c) TPC-D should submit detailed list of actions and efforts undertaken by it prior to and during FY 2015-16 to ensure compliance of its RPO targets in respect of Solar RPO, Non-solar RPO and Mini/Micro hydro RPO for FY 2015-16.
- d) TPC-D should submit the details for long term RE procurement plan for meeting the RPO targets for FY 2016-17.

#### Response

#### Solar RPO

With respect to Solar RPO, we wish to submit that, Tata Power-D has met the standalone target of FY 2015-16 of 30.10 MUs. With respect to the cumulative solar RPO compliance, we had a cumulative shortfall of 43.83 MUs approved by the Hon'ble Commission in its Order in Case No. 18 of 2016 dated 31<sup>st</sup> August 2016. This shortfall has been subsequently met in FY 2015-16 and Tata Power-D now has a cumulative surplus of 0.22 MUs.

With regards to long term RE procurement plan for meeting Solar RPO targets for FY 2016-17, we wish to submit that following the commissioning of the 25 MW solar plant of TPREL, Tata Power-D would have excess generation from its contracted capacities to meet the requirement for FY 2016-17. In view of this, Tata Power-D would be in a position to fulfill the solar RPO requirement for FY 2016-17 with the help of contracted capacities and solar RECs procured through Exchange.

The Hon'ble Commission is aware that the sales of Tata power-D is inclusive of sales from changeover consumer which is depend on tariff differential of another parallel licensee. Hence, additional tie up is depend upon the actual realization of sales post MYT Tariff Order Tata Power-D will tie up additional long term capacity to meet its Solar requirement considering the above aspect. Further, the generic tariff approved in the *Suo-Moto* RE tariff Order in Case 45 of 2016 by the Hon'ble Commission is <u>Rs 6.04 per kWh</u> for the year FY 2016-17 which is on the higher side in comparison with the current discovered prices in the market. Hence, Tata Power-D will tie up the future capacity when the approved tariff will match the current prices in the market or if it gets lower offer price than Rs 6.04 /- kWh.

#### **Non Solar RPO**

Tata Power-D has met the Non-Solar obligation for FY 2015-16. Further, Tata Power-D has sufficient contracted capacity already tied up to meet Non-Solar RPO for FY 2016-17 as shown in Table 8 below. Further, as explained earlier till the sales of Tata Power-D has not been stabilize any expected shortfall shall be met by procuring Non-Solar RECs on the Exchange.

#### Mini/Micro Hydro RPO

In line with the directives of the Hon'ble Commission, Tata Power-D has taken significant efforts to procure energy from Mini/Micro Hydro projects prior to and during the year FY 2015-16, which have been elaborated further below:

- a) Tata Power-D floated a tender on 25<sup>th</sup> November, 2014 (**Annexure I**) and published advertisements in newspapers (English & Marathi language) on 29<sup>th</sup> November, 2014 for procurement of Mini-Micro Hydro Power (**Annexure II**). However Tata Power-D did not receive a single response for these tender.
- b) Tata Power-D once again floated tender on 22<sup>nd</sup> June, 2015 (**Annexure III**) and published advertisements in newspapers (English & Marathi language) on 29<sup>th</sup> June, 2015 for procurement of Mini-Micro Hydro Power (**Annexure IV**). However, for this tender also, Tata Power-D did not receive a single response.
- c) Further, Tata Power-D approached Mini/Micro Hydro generator M/s. Water Resource Technologies Pvt. Limited (Annexure V). However, its plant is proposed to commission in the year FY 2016-17 and there has been no development in this regard.

- d) Subsequently, Tata Power-D has floated a tender on 24<sup>th</sup> November 2016 (Annexure VI) for procurement of Mini/Micro Hydro power for which it has received no responses so far.
- e) Meanwhile, Tata Power-Generation (Tata Power-G) is exploring the development of Mini/Micro Hydro projects at its Hydro Generating Plants. As and when these projects fructify, Tata Power-D proposes to tie up these capacities for meeting the Mini/Micro Hydro RPO.
- f) In spite of the above efforts, Tata power-D has been unable to achieve its obligation with respect to Mini/Micro Hydro RPO. In view of this based on the Hon'ble Commission Order Tata Power-D shall purchase Non-Solar RECs during FY 2016-17 in order to meet its cumulative shortfall if any till FY 2016-17 and thus meets its Mini/Micro Hydro RPO targets.


