Subject: Petition of Reliance Infrastructure Limited (Generation) (RInfra-G) and Reliance Infrastructure Limited – Distribution (RInfra-D) under Section 86 (1) (a), 86(1) (b) of EA 2003 and Regulation 20.1 of MERC MYT Regulations, 2015 for approval of Power Purchase Arrangement between Reliance Infrastructure Limited – Generation (RInfra-G) and Reliance Infrastructure Limited – Distribution (RInfra-D)

- **Case No. 05 of 2017**

Reliance Infrastructure Limited (Generation) (RInfra-G) and Reliance Infrastructure Limited – Distribution (RInfra-D) has filed a Petition on 23.12.2016 under Section 86 (1) (a), 86(1) (b) of EA03 and Regulation 20.1 of MERC MYT Regulations, 2015 for approval of Power Purchase Arrangement between Reliance Infrastructure Limited – Generation (RInfra-G) and Reliance Infrastructure Limited – Distribution (RInfra-D)

The main prayers of the Petitioner are as under-

- a. *Approve the Power Purchase Arrangement (Annexure-7 along with Exhibit-1 hereto) relating to supply of 500 MW by RInfra-G to RInfra-D for the period 23-02-2018 to 15-08-2036;*
- b. *For such further and other reliefs as the nature and circumstances of the case may require;*
- c. *Pass any other Order as may be appropriate under the circumstances.*

2. 6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.

7. The Petitioner herein is directed to file a service report / copy of acknowledgement of serving of copies of the Petition upon the Respondents prior to the hearing in the matter.
