Subject: Petition of The Brihan Mumbai Electric Supply & Transport Undertaking (BEST) for Approval of Power Procurement Plan for FY 2018-19 to FY 2027-28 for the BEST Undertaking under Regulation 19 & 20 of MERC (MYT) Regulations, 2015.

- **Case No. 25 of 2017**

The Brihan Mumbai Electric Supply & Transport Undertaking (BEST) has submitted a Petition under affidavit on 27.01.2017, for Approval of Power Procurement Plan for FY 2018-19 to FY 2027-28 for the BEST Undertaking under Regulation 19 & 20 of MERC (MYT) Regulations, 2015.

The main prayers of the Petitioner are as under-

- a. *Admit this petition under Regulation 19 and 20 of the Maharashtra Electricity Regulatory Commission (Multi Year Tariff) Regulations, 2015.*
- b. *Approve this Power Procurement Plan on priority basis considering paucity of time.*
- c. *Approve procurement of 300MW of power from Case-I bidding and 500 MW of power from TPC-G under extension;/or MSEDCL.*
- d. *Condone any inadvertent omission/errors and grant the liberty to BEST to add/change/modify / alter this petition and make further submissions as may be required at a future date.*
- e. *Pass such further and other orders, as the Commission may deem fit and proper, keeping in view the facts and circumstances of the case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 09 March, 2017 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. I am directed to communicate that; the Commission has impleaded TPC-G, MSEDCL, and STU as Respondents.

4. The Petitioner is directed to serve within 1 week, a copy of its above Petition (both in soft and hard copy) to the impleaded Respondents and the authorised institutional Consumer Representatives.
